I request that the following be funded:

- to the public education department

LOVINGTON MSD LACES & HEALTH CTR ACCESS IMPROVE

one hundred twenty-five thousand dollars (\$125,000) to plan, design and construct a dropoff lane, fencing and parking improvements to the Lovington autism center for educational services and the site-based health clinic of the Lovington municipal school district in Lea county

- to the department of environment

HOBBS SEWER TRUNK LINE CONSTRUCT & REPLACE

twelve million dollars (\$12,000,000) to plan, design, construct, remove and replace sewer trunk lines and manholes, including bypass pumping and materials disposal, in Hobbs in Lea county

HOBBS WWATER AEROBIC DIGESTION BASINS & EQUIP

seven million six hundred thousand dollars (\$7,600,000) to design, construct, renovate, expand and equip aerobic digestion basins at the wastewater reclamation facility in Hobbs in Lea county

HOBBS WWATER AQUIFER RECHARGE/RECOVERY SYS

two million four hundred fifty thousand dollars (\$2,450,000) to construct and equip an aquifer recharge and recovery system for the wastewater reclamation facility in Hobbs in Lea county

HOBBS WWATER RECLAMATION TRTMNT PROCESS CONSTRUCT

two million dollars (\$2,000,000) to plan, design and construct a tertiary treatment process system at the wastewater reclamation facility in Hobbs in Lea county

TATUM WATER SYSTEM IMPROVE

fifty thousand dollars (\$50,000) to plan, design and construct water system improvements, including replacing water lines and the purchase and installation of hydrants and meters, in Tatum in Lea county

EUNICE FIRE STATION CONSTRUCT EQUIP

seven hundred thousand dollars (\$700,000) to plan, design, purchase, construct and equip a fire station in Eunice in Lea county

JAL LITTLE LEAGUE BB FIELD

five hundred thousand dollars (\$500,000) to plan, design, construct, improve, furnish and equip a little league baseball field and complex, including lighting, fencing, dugouts, restrooms, irrigation, bleachers and parking, in Jal in Lea county

LEA CO DETENTION CTR EXPAND

one million six hundred thousand dollars (\$1,600,000) to plan, design, construct and equip an expansion, including separate areas for male and female mental health patient inmates, at the Lea county detention center in Lovington in Lea county

LEA CO JUDICIAL CMPLX CONSTRUCT

four million seven hundred fifty thousand dollars (\$4,750,000) to plan, design, construct, purchase and install fixtures, equipment and furnishings, including a security screener and cameras, access control, fire alarms, automated heating, ventilation and air conditioning and audiovisual court and courtroom directions systems, for a county judicial complex in Lovington in Lea county

LOVINGTON AERIAL FIREFIGHTING APPARATUS

one million five hundred thousand dollars (\$1,500,000) to purchase and equip an aerial firefighting apparatus for the fire department in Lovington in Lea county

LOVINGTON FIRING RANGE CONSTRUCT EQUIP

two hundred fifty-four thousand dollars (\$254,000) to plan, design, construct and equip a firing range for law enforcement agencies in Lovington in Lea county

LOVINGTON INDUSTRIAL PK INFRA

two million three hundred thousand dollars (\$2,300,000) to plan, design, construct and improve infrastructure, including utilities and roads, at the Lovington industrial park in Lovington in Lea county

two million eight hundred thousand dollars (\$2,800,000) to plan, design, construct and equip a sports complex in Lovington in Lea county

three million eight hundred seventy thousand dollars (\$3,870,000) to plan, design, construct and equip an expansion to the passenger terminal at the Lea county regional airport in Hobbs in Lea county

N COMMERCIAL ST BYPASS CONSTRUCT LOVINGTON

two million nine hundred fifty-eight thousand nine hundred twelve dollars (\$2,958,912) to plan, design, construct and make improvements to the north Commercial street bypass in Lovington in Lea County

NMJC ALLIED HEALTH BLDG EQUIP HOBBS

five hundred thousand dollars (\$500,000) to purchase equipment for the allied health program and to plan, design and construct an allied health building on the campus of New Mexico junior college in Hobbs in Lea county
