examination of a sexual assault victim who reported the

 the agency's receipt of the sample.

B. Records derived from DNA testing that qualify for insertion into CODIS shall be submitted by the servicing laboratory to the administrative center.

9 C. By November 1 of each year, a law enforcement 10 agency's servicing laboratory shall report to the legislature 11 if, at the end of the immediately preceding fiscal year, the 12 laboratory had in its possession three hundred or more 13 untested samples of biological material collected pursuant to 14 medical examinations of sexual assault victims.

D. As used in this section:

16 (1) "administrative center" means the law 17 enforcement agency or unit that administers and operates the 18 DNA identification system pursuant to the provisions of the 19 DNA Identification Act;

(2) "biological material" means material
that is derived from a human body and includes bodily fluids,
hair and skin cells;

(3) "CODIS" means the federal bureau of
investigation's "combined DNA index system", a national DNA
index system for storage and exchange of DNA records
