## A JOINT RESOLUTION

PROPOSING AMENDMENTS TO ARTICLE 6 OF THE CONSTITUTION OF NEW MEXICO TO GIVE THE LEGISLATURE AUTHORITY TO PROVIDE FOR APPELLATE JURISDICTION BY STATUTE.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. It is proposed to amend Article 6, Section 13 of the constitution of New Mexico to read:

9 "The district court shall have original jurisdiction in 10 all matters and causes not excepted in this constitution, and 11 such jurisdiction of special cases and proceedings as 12 provided by law, and appellate jurisdiction of cases 13 originating in inferior courts and tribunals in their 14 respective districts as provided by law, and supervisory 15 control over the same. The district courts, or any judge 16 thereof, shall have power to issue writs of habeas corpus, 17 mandamus, injunction, quo warranto, certiorari, prohibition 18 and all other writs, remedial or otherwise, in the exercise 19 of their jurisdiction; provided that no such writs shall 20 issue directed to judges or courts of equal or superior 21 jurisdiction. The district courts shall also have the power 22 of naturalization in accordance with the laws of the 23 United States. Until otherwise provided by law, at least two 24 terms of the district court shall be held annually in each 25 county, at the county seat."
