7	(\$7,500) in matching funds to the law enforcement officer; and
8	(c) the distribution and the matching

13	B. For the academy, amounts distributed from the

17	C. Amounts distributed from the fund shall be
18	expended only pursuant to approved budgets and upon duly
19	executed vouchers approved as required by law."
