15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 8-1-1 NMSA 1978 (being Laws 1971,
17	Chapter 260, Section 1, as amended) is amended to read:
18	"8-1-1. COMPENSATION OF ELECTIVE STATE OFFICERS
19	A. Annual compensation of elective state officers
20	shall be paid as follows:
21	governor [ <del>\$110,000</del> ] <u>\$121,000</u>
22	secretary of state
23	state auditor [ <del>85,000</del> ] <u>93,500</u>
24	state treasurer [ <del>85,000</del> ] <u>93,500</u>
25	attorney general [ <del>95,000</del> ] <u>104,500</u>

Any person succeeding to the office of governor Β. as provided in Article 5, Section 7 of the constitution of New Mexico shall receive the salary of the office. Every person serving as acting governor during the incapacity or absence of the governor from the state, other than the secretary of state, shall receive two hundred fifty dollars (\$250) as compensation 8 for each day's service as acting governor.

All compensation under this section shall be C. paid from the general fund, except that the amount paid to the 12 commissioner of public lands shall be paid from the state lands maintenance fund."

SECTION 2. Section 8-3-3 NMSA 1978 (being Laws 1971, Chapter 138, Section 3, as amended) is amended to read:

"8-3-3. COMPENSATION. -- For the performance of the duties established in Section 8-3-1 NMSA 1978, the lieutenant governor shall receive an annual compensation of [<del>eighty-five thousand</del> dollars (\$85,000)] ninety-three thousand five hundred dollars (\$93,500)."

**SECTION 3.** APPLICABILITY.--The compensation increases provided for by this act apply to elective state officers whose terms of office begin on or after January 1, 2019.
