I request that the following be funded:

- to the district attorney of the fifth judicial district

5TH JUDICIAL DISTRICT ATTORNEY FURNITURE

twenty-five thousand dollars (\$25,000) to furnish the offices of the fifth judicial district attorney in the county judicial complex in Lovington in Lea county

- to the public education department

LLANO ELEM SCHL PRE-K & KINDERGARTEN SECURITY

fifty thousand dollars (\$50,000) to plan, design and construct security entrances for the kindergarten and pre-kindergarten building, including purchase and installation of security equipment, cameras and control systems, at Llano elementary school in the Lovington municipal school district in Lea county

LOVINGTON MSD AUDITORIUM SOUND SYSTEM

fifty thousand dollars (\$50,000) to plan, design, purchase and install a sound system in the Lovington municipal school district auditorium in Lea county

LOVINGTON MSD AUTISM CENTER RESTROOM

fifty thousand dollars (\$50,000) to plan, design and construct a staff and special needs restroom for the Lovington autism center for educational services building in the Lovington municipal school district in Lea county

LOVINGTON MSD SECURITY FENCING

forty-five thousand dollars (\$45,000) to plan, purchase and install security fencing at Jefferson elementary school, Sixth Grade academy, Yarbrow elementary school, Gann cafeteria and Lovington high school in the Lovington municipal school district in Lea county

TATUM MSD SECURITY SYSTEM

one hundred thirty-six thousand eight hundred dollars (\$136,800) to design, purchase and install a security system for the Tatum municipal school district in Lea county

CARLSBAD BRINE WELL REMEDIATION

thirty-five million dollars (\$35,000,000) to plan, design and construct the remediation of a brine well at unit letter M (SW/4 of SW/4) in section seventeen, township twenty-two, range twenty-seven east, New Mexico principal meridian, in Carlsbad in Eddy county

HOBBS SEWER TRUNK LINE CONSTRUCT & REPLACE

nine million dollars (\$9,000,000) to design, construct and replace sewer trunk lines and manholes, including bypass pumping and materials disposal, in Hobbs in Lea county

HOBBS WWATER AEROBIC DIGESTION BASINS & EQUIP

two hundred thousand dollars (\$200,000) to construct aerobic digestion basins and purchase, construct and install pumping equipment at the wastewater reclamation facility in Hobbs in Lea county

HOBBS WWATER AQUIFER RECHARGE/RECOVERY SYS

one hundred thousand dollars (\$100,000) to construct an aquifer recharge and recovery system for the wastewater reclamation facility in Hobbs in Lea county

HOBBS WWATER RECLAMATION FACILITY COVER

one hundred thousand dollars (\$100,000) to design and construct a stabilization basin cover system at the wastewater reclamation facility in Hobbs in Lea county

JAL WATER WELLS

one million two hundred thousand dollars (\$1,200,000) to plan, design and construct water wells, appurtenances and collection lines in Jal in Lea county

TATUM WATER STORAGE TANK

one hundred fifty thousand dollars (\$150,000) to repair and make improvements to the main water storage tank in Tatum in Lea county

one hundred thousand dollars (\$100,000) to plan, design, construct, purchase and install water system improvements in Tatum in Lea county

one hundred eighty-four thousand five hundred dollars (\$184,500) to purchase patient beds for Nor-Lea general hospital in the Nor-Lea special hospital district in Lea county

EUNICE ANIMAL SHELTER FACILITY

two hundred thousand dollars (\$200,000) to plan, design, purchase, construct, equip and landscape a temporary animal shelter facility, including utilities installation, in Eunice in Lea county

EUNICE PUBLIC SAFETY COMPLEX

six hundred twenty-five thousand dollars (\$625,000) to plan, design, construct, remodel, furnish and equip a public safety complex in Eunice in Lea county

LEA CO SPECIAL EVENTS ARENA RENOVATE

seven million three hundred sixty-five thousand dollars (\$7,365,000) to plan, design, construct, purchase and install improvements and renovations at the Lea county special events arena, grounds and parking lot, including accessibility improvements, in Hobbs in Lea county

JAL BASKETBALL & TENNIS COURTS

two hundred fifty thousand dollars (\$250,000) to design and construct improvements to basketball and tennis courts in Jal in Lea county

JAL CEMETERY IMPROVE

two hundred twenty thousand dollars (\$220,000) to plan, design, construct, purchase and install site improvements, fencing, landscaping, irrigation improvements and a bathroom at the cemetery in Jal in Lea county

JAL PUBLIC SAFETY COMPLEX SALLY PORT

two hundred sixty thousand dollars (\$260,000) to plan, design, construct, furnish and equip a sally port for the public safety complex in Jal in Lea county

one million dollars (\$1,000,000) to plan, design, construct, furnish and equip a teen and community center in Jal in Lea county

sixteen million five hundred thousand dollars (\$16,500,000) to plan, design, construct, improve, renovate, expand, equip and furnish the county courthouse, including heating, ventilation and air conditioning improvements and purchase and installation of information technology and related infrastructure, in Lovington in Lea county

LOVINGTON AERIAL FIREFIGHTING LADDER TRUCK

one million five hundred thousand dollars (\$1,500,000) to purchase and equip an aerial firefighting ladder truck for the fire department in Lovington in Lea county

LOVINGTON FIRING RANGE CONSTRUCT EQUIP

one hundred eighty-four thousand dollars (\$184,000) to plan, design, construct, renovate and equip a firing range in Lovington in Lea county

LOVINGTON SPORTS COMPLEX CONSTRUCT

nine hundred forty thousand dollars (\$940,000) to plan, design, construct and equip a sports complex in Lovington in Lea county

LEA CO RGNL AIRPORT TERMINAL EXPAND

eleven million five hundred thousand dollars (\$11,500,000) to plan, design and construct an expansion to the terminal at the Lea county regional airport in Hobbs in Lea county

NM HWY 128 IMPROVE - JAL

three hundred fifty thousand dollars (\$350,000) to plan, design, construct, purchase and install improvements to New Mexico highway 128, including lighting, landscaping and accessible sidewalks and crosswalks, in Jal in Lea county

N COMMERCIAL ST BYPASS CONSTRUCT LOVINGTON

one million three hundred sixty-one thousand nine hundred twenty-one dollars (\$1,361,921) to plan, design, construct and make improvements to the north Commercial street bypass in Lovington in Lea County
