AN ACT

MAKING AN APPROPRIATION FOR SERVICES FOR SENIOR CITIZENS
THROUGHOUT NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. APPROPRIATION.--

A. The following amounts are appropriated from the general fund to the aging and long-term services department for expenditure in fiscal year 2020 HHHC → and subsequent fiscal years ← HHHC to fund the following programs and services:

(1) HHHC → ~~one million two hundred ninety-five thousand seven hundred thirty-eight dollars (\$1,295,738)~~ one million nine hundred four thousand one hundred sixty-one

dollars (\$1,904,161) ← HHHC for the following senior services delivered through the four area agencies on aging:

- (a) adult daycare;
- (b) case management;
- (c) congregate meals;
- (d) home-delivered meals;
- (e) in-home services;
- (f) transportation; and
- (g) senior center services;

(2) HHHC → ~~one hundred six thousand ninety dollars (\$106,090)~~ one hundred fifty-five thousand nine hundred five dollars (\$155,905) ← HHHC for volunteer programs, including foster grandparents, senior companions and retired senior volunteers;

(3) HHHC → ~~thirty-five thousand twenty dollars (\$35,020)~~ fifty-one thousand four hundred sixty-four dollars (\$51,464) ← HHHC to fund evidence-based Alzheimer's programming in northern New Mexico;

(4) HHHC → ~~thirty-seven thousand eighty dollars (\$37,080)~~ fifty-four thousand four hundred ninety-one dollars (\$54,491) ← HHHC to fund competitive athletic and fitness programming for seniors; and

(5) HHHC → ~~ten thousand dollars (\$10,000)~~ fifteen thousand one hundred thirty-six dollars (\$15,136) ← HHHC to fund legal services for seniors.
