The delivery of firearms that have been ordered relinquished pursuant to Subparagraph (a) of Paragraph (2) of Subsection A of Section 40-13-5 NMSA 1978 shall occur by the restrained party delivering firearms in the restrained party's immediate possession or control to a third party who is not prohibited from possessing a firearm by state or federal law on or before the end of the next day following the day on which the restrained party is served with the order of protection. To deliver the firearm, the restrained party may:

(1) sell or deliver the firearm for safekeeping to a federally licensed firearms dealer;
