10 AN ACT

11 RELATING TO LICENSURE; PROVIDING FOR A WAIVER OF FEES FOR AND
12 ISSUANCE OF CERTAIN PROFESSIONAL AND OCCUPATIONAL LICENSES FOR
13 MILITARY SERVICE MEMBERS, SPOUSES AND THEIR DEPENDENT CHILDREN.

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 SECTION 1. A new section of the Uniform Licensing Act is
17 enacted to read:

18 "[NEW MATERIAL] EXPEDITED LICENSURE--ISSUANCE--WAIVER OF
19 FEES--MILITARY SERVICE MEMBERS, SPOUSES AND DEPENDENT
20 CHILDREN.--

21 A. Notwithstanding any other section of Chapter 61
22 NMSA 1978, a state agency, board or commission that issues a
23 professional or occupational license pursuant to Chapter 61,
24 Articles 2 through 14E, 17A, 24, 24A and 31 NMSA 1978 shall, as
25 soon as practicable after a military service member files an

1 application for a license:

2 (1) waive all required fees and process the
3 application; and

4 (2) issue a license valid for a term of three
5 years to a qualified applicant who submits satisfactory
6 evidence that the applicant:

7 (a) holds a license that is current and
8 in good standing issued by another jurisdiction in the United
9 States and that is substantially equivalent to the professional
10 or occupational license the applicant applies for pursuant to
11 Chapter 61, Articles 2 through 14E, 17A, 24, 24A and 31 NMSA
12 1978;

13 (b) has provided fingerprints and other
14 information necessary for a state and national criminal
15 background check, if required; and

16 (c) moved to New Mexico within one year
17 of filing an application for license pursuant to this section.

18 B. A license issued pursuant to this section is not
19 a provisional license and confers the same rights, privileges
20 and responsibilities as a license issued pursuant to Chapter
21 61, Articles 2 through 14E, 17A, 24, 24A and 31 NMSA 1978. A
22 license issued pursuant to this section shall not be renewed
23 pursuant to the provisions of this section.

24 C. As used in this section, "military service
25 member" means:

1 (1) a person who is serving in the armed
2 forces of the United States or in an active reserve component
3 of the armed forces of the United States, including the
4 national guard;

5 (2) that person's spouse; or

6 (3) that person's child who is also a
7 dependent for federal income tax purposes."

8 SECTION 2. EFFECTIVE DATE.--The effective date of the
9 provisions of this act is July 1, 2019.
