admissible. In actions upon malpractice claims tried to the court, where liability is found, the court's findings shall include a recitation that the patient is or is not in need of future medical care and related benefits.

Except as provided in Section 41-5-10 NMSA 1978, Β. once a judgment is entered in favor of a patient who is found to be in need of future medical care and related benefits or a 7 8 settlement is reached between a patient and health care provider in which the provision of medical care and related benefits is agreed upon, and continuing as long as medical or 10 surgical attention is reasonably necessary, the patient shall 12 be furnished with all medical care and related benefits directly or indirectly made necessary by the health care provider's malpractice, subject to a semi-private room limitation in the event of hospitalization, unless the patient refuses to allow them to be so furnished.

Awards of future medical care and related C. benefits shall not be subject to the [six hundred thousand dollar (\$600,000) limitation imposed in] applicable limitations imposed in Subsection A of Section 41-5-6 NMSA 1978.

Payment for medical care and related benefits D. shall be made as expenses are incurred.

Ε. The health care provider shall be liable for all medical care and related benefit payments until the total payments made by or on behalf of it for monetary damages and

medical care and related benefits combined equals two hundred thousand dollars (\$200,000), after which the payments shall be made by the patient's compensation fund.

F. This section shall not be construed to prevent a patient and a health care provider from entering into a settlement agreement whereby medical care and related benefits shall be provided for a limited period of time only or to a limited degree.

G. The court in a supplemental proceeding shall estimate the value of the future medical care and related benefits reasonably due the patient on the basis of evidence presented to it. That figure shall not be included in any award or judgment but shall be included in the record as a separate court finding.

H. A judgment of punitive damages against a health care provider shall be the personal liability of the health care provider. Punitive damages shall not be paid from the patient's compensation fund or from the proceeds of the health care provider's insurance contract unless the contract expressly provides coverage. Nothing in Section 41-5-6 NMSA 1978 precludes the award of punitive damages to a patient. Nothing in this subsection authorizes the imposition of liability for punitive damages on a derivative basis where that imposition would not be otherwise authorized by law."

1 2 Chapter 33, Section 9, as amended) is amended to read: "41-5-25. PATIENT'S COMPENSATION FUND.--

There is created in the state treasury a Α. 3 "patient's compensation fund" to be collected and received by 4 the superintendent for exclusive use for the purposes stated in 5 the Medical Malpractice Act. The fund and any income from it 6 7 shall be held in trust, deposited in a segregated account and invested and reinvested by the superintendent with the prior 8 9 approval of the state board of finance and shall not become a part of or revert to the general fund of this state. The fund 10 and any income from the fund shall only be expended for the 11 12 purposes of and to the extent provided in the Medical Malpractice Act. The superintendent shall have the authority 13 14 to use fund money to purchase insurance for the fund and its The superintendent is also authorized to use fund obligations. 15 money to purchase reinsurance adequate to ensure the fund's 16 ability to respond to a judgment or judgments in the amount of 17 at least twenty-five million dollars (\$25,000,000) per 18 occurrence based on sound actuarial principles. 19 The 20 superintendent, as custodian of the patient's compensation fund, shall be notified by the health care provider or [his] 21 the health care provider's insurer within thirty days of 22 service on the health care provider of a complaint asserting a 23 malpractice claim brought in a court in this state against the 24 health care provider. 25

B. To create the patient's compensation fund, an annual surcharge shall be levied on all health care providers qualifying under Paragraph (1) of Subsection A of Section 41-5-5 NMSA 1978 in New Mexico. The surcharge shall be determined by the superintendent based upon sound actuarial principles, using data obtained from New Mexico experience if available. The surcharge shall be collected on the same basis as premiums by each insurer from the health care provider.

C. The surcharge with accrued interest shall be due and payable within thirty days after the premiums for malpractice liability insurance have been received by the insurer from the health care provider in New Mexico.

D. If the annual premium surcharge is collected but not paid within the time limit specified in Subsection C of this section, the certificate of authority of the insurer may be suspended until the annual premium surcharge is paid.

E. All expenses of collecting, protecting and administering the patient's compensation fund or of purchasing insurance for the fund shall be paid from the fund.

F. Claims payable pursuant to Laws 1976, Chapter 2, Section 30 shall be paid in accordance with the payment schedule constructed by the court. If the patient's compensation fund would be exhausted by payment of all claims allowed during a particular calendar year, then the amounts paid to each patient and other parties obtaining judgments

1 shall be prorated, with each such party receiving an amount 2 equal to the percentage [his] the party's own payment schedule 3 bears to the total of payment schedules outstanding and payable by the fund. Any amounts due and unpaid as a result of such 4 proration shall be paid in the following calendar years. 5 However, payments for medical care and related benefits shall 6 7 be made before any payment made under Laws 1976, Chapter 2, Section 30. 8

Upon receipt of one of the proofs of 9 G. authenticity listed in this subsection, reflecting a judgment 10 for damages rendered pursuant to the Medical Malpractice Act, 11 12 the superintendent shall issue or have issued warrants in accordance with the payment schedule constructed by the court 13 and made a part of its final judgment. The only claim against 14 the patient's compensation fund shall be a voucher or other 15 appropriate request by the superintendent after [he] the 16 superintendent receives: 17

(1) a certified copy of a final judgment in excess of two hundred thousand dollars (\$200,000) against a health care provider;

(2) a certified copy of a court-approved settlement or certification of settlement made prior to initiating suit, signed by both parties, in excess of two hundred thousand dollars (\$200,000) against a health care provider; or

(3) a certified copy of a final judgment less than two hundred thousand dollars (\$200,000) and an affidavit of a health care provider or its insurer attesting that payments made pursuant to Subsection E of Section 41-5-7 NMSA 1978, combined with the monetary recovery, exceed two hundred thousand dollars (\$200,000).

H. The superintendent shall contract for an independent actuarial study of the patient's compensation fund to be performed not less than once every two years."

SECTION 6. A new section of the Medical Malpractice Act is enacted to read:

"[<u>NEW MATERIAL</u>] DISCLOSURE OF PERSONAL INFORMATION PROHIBITED.--It is unlawful for any employee or former employee of the state to disclose to any other person, other than an employee of the state in connection with that employee's official duties, any personal information about a health care provider that has settled a claim for malpractice covered by the Medical Malpractice Act."

SECTION 7. A new section of the Medical Malpractice Act is enacted to read:

"[NEW MATERIAL] ADVISORY COMMITTEE--MEMBERS--DUTIES.--

A. The "Medical Malpractice Act advisory committee" is created. The advisory committee shall consist of seven members as follows:
