AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE;

MAKING AN APPROPRIATION TO THE INDIAN AFFAIRS DEPARTMENT FOR

LIBRARY AND INTERNET ACCESS PROJECTS FOR INDIAN NATIONS, TRIBES

AND PUEBLOS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. APPROPRIATION. --

- A. Thirty-six million forty-three thousand one hundred twenty-two dollars (\$36,043,122) is appropriated from the general fund to the Indian affairs department for expenditure in fiscal years 2019 through 2023 for the following purposes:
- (1) twenty-seven million three hundred ninety-three thousand one hundred twenty-two dollars (\$27,393,122) to plan, design, renovate, expand, construct, equip and furnish
