15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 57-12-2 NMSA 1978 (being Laws 1967,
17	Chapter 268, Section 2, as amended) is amended to read:
18	"57-12-2. DEFINITIONSAs used in the Unfair Practices
19	Act:
20	A. "person" means, where applicable, natural
21	persons, corporations, trusts, partnerships, associations,
22	cooperative associations, clubs, companies, firms, joint
23	ventures or syndicates;
24	B. "seller-initiated telephone sale" means a sale,
25	lease or rental of goods or services in which the seller or the

seller's representative solicits the sale by telephoning the prospective purchaser and in which the sale is consummated entirely by telephone or mail, but does not include a transaction:

5 (1) in which a person solicits a sale from a

8 (2) in which the purchaser is accorded the
9 right of rescission by the provisions of the federal Consumer
10 Credit Protection Act, 15 U.S.C. 1635, or regulations issued
11 pursuant thereto;

C. "trade" or "commerce" includes the advertising, offering for sale or distribution of any services and any property and any other article, commodity or thing of value, including any trade or commerce directly or indirectly affecting the people of this state;

D. "unfair or deceptive trade practice" means an act specifically declared unlawful pursuant to the Unfair Practices Act, a false or misleading oral or written statement, visual description or other representation of any kind knowingly made in connection with the sale, lease, rental or loan of goods or services or in the extension of credit or in the collection of debts by a person in the regular course of the person's trade or commerce, that may, tends to or does deceive or mislead any person and includes:
