17	SECTION 1. [<u>NEW MATERIAL</u>] SHORT TITLEThis act may be
18	cited as the "Office of Peacebuilding Act".
19	SECTION 2. [<u>NEW MATERIAL</u>] DEFINITIONSAs used in the
20	Office of Peacebuilding Act:
21	A. "council" means the citizens peacebuilding

"director" means the director of the office;

3 D. "office" means the office of peacebuilding; and 4 Ε. "restorative justice" means a facilitated 5 process allowing everyone involved in a conflict to be heard, to acknowledge responsibility for harm caused, to seek ways to 6 7 repair the harm and to restore relationships and community. 8 SECTION 3. [NEW MATERIAL] OFFICE ESTABLISHED.--The 9 "office of peacebuilding" is created. The office is administratively attached to the department of finance and 10 administration. For purposes of this section, the term 11 12 "administratively attached" has the meaning specified in Section 9-1-7 NMSA 1978. 13

SECTION 4. [<u>NEW MATERIAL</u>] DIRECTOR--APPOINTMENT.--

A. The administrative head of the office is the "director of the office of peacebuilding", who shall be appointed by the governor with the consent of the senate.

B. The director shall be an administrator who has shown successful administrative experience and has no fewer than eighty hours of training in alternative dispute resolution, mediation, dialogue or restorative justice and at least two years of experience in applying these skills in a community setting or equivalent life experience.

C. The director shall serve and have all the duties, responsibilities and authority of the office during the .213875.1

3	SECTION 5. [<u>NEW MATERIAL</u>] DIRECTORPOWERS AND DUTIES
4	A. The director shall:
5	(1) be responsible to the governor for the
6	operation of the office;

8	(3) apply the resources and skills of the
9	office statewide to:
10	(a) the prevention, management and
11	resolution of conflict;
12	(b) public education on peace and

17	(d) the development of a peace education

assistance, contractors and general counsel as deemed necessary and oversee staff performance, setting priorities within time and budget constraints; and

4 (4) accept grants and gifts on behalf of the5 office.

SECTION 6. [<u>NEW MATERIAL</u>] COUNCIL--CREATION--MEMBERS--RESPONSIBILITIES.--

8 A. The "citizens peacebuilding advisory council" is 9 created and shall be composed of the director and eleven 10 appointed members as follows, who reflect a concern for the 11 integrity of the environment, the creative imagination of the 12 arts and the multicultural, gender, economic, geographic and 13 political diversity of the people of New Mexico:

(1) two representatives from established state or local peace advocacy organizations, appointed by the director;

(2) one representative from the New Mexicofaith community, appointed by the director;

(3) one representative from a local, county or state law enforcement agency who has specialized in violence prevention, appointed by the secretary of public safety;

(4) one health professional with expertise in behavioral and public health issues, appointed by the secretary of health;

(5) one professional mediator, appointed by .213875.1

2 one veteran who has served in an armed (6) 3 conflict, appointed by the secretary of veterans' services; 4 (7) one public school educator with knowledge 5 of peace curriculum development, appointed by the secretary of public education; 6 7 (8) one representative of the university of New Mexico's peace studies program, appointed by the governor; 8 9 (9) one youth representative, between the ages of fifteen and twenty-four years, appointed by the governor; 10 and 11 12 (10) one member appointed by the secretary of Indian affairs. 13 The term of service of appointed council members 14 Β. shall be four years. The initial terms shall be staggered so 15 that the terms of six members shall expire at the end of the 16 initial two years, and the terms of five members shall expire 17 at the end of the initial four years. The initial terms shall 18 be selected by random drawing. A member of the council shall 19 not serve more than two full terms. In the event of a vacancy 20 on the council, a new member shall be appointed by the original 21 appointing authority for the unexpired term. 22 23

C. The council shall select a chair, a vice chair and other officers as it deems necessary.

D. The council shall meet no less than twice .213875.1

16	E. Council members shall receive per diem and
17	mileage as provided for nonsalaried public officers in the Per
18	Diem and Mileage Act and shall receive no other compensation,
19	perquisite or allowance.
20	F. The office shall provide for its own space and
21	for the space and administrative needs of the council.
22	SECTION 7. APPROPRIATIONFive hundred thousand dollars
23	(\$500,000) is appropriated from the general fund to the office
24	of peacebuilding for expenditure in fiscal year 2020 and
25	subsequent fiscal years to carry out the purposes of the Office
