17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. A new section of Chapter 72, Article 14 NMSA
19	1978 is enacted to read:
20	"[<u>NEW MATERIAL</u>] ACEQUIA AND COMMUNITY DITCH INFRASTRUCTURE
21	FUNDCREATED
22	A. The "acequia and community ditch infrastructure
23	fund" is created in the state treasury and shall be
24	administered by the interstate stream commission. The fund
25	consists of money distributed from the New Mexico irrigation

1 works construction fund and interest accruing to the fund. 2 Disbursements from the fund shall be made by warrant of the 3 secretary of finance and administration pursuant to vouchers 4 signed by the director of the interstate stream commission or 5 the director's authorized representative. Any unexpended or 6 unencumbered balance remaining in the fund at the end of any 7 fiscal year shall revert to the New Mexico irrigation works 8 construction fund.

9 B. Money in the fund is appropriated to the10 interstate stream commission to provide funding for:

(1) seventeen and one-half percent of the total cost of work undertaken by the United States army corps of engineers pursuant to the federal Water Resources Development Act of 1986 to preserve and restore acequia or community ditch diversion structures and associated canals; provided that:

(a) an acequia or community ditch shall provide seven and one-half percent of the total cost of the work from a source other than the New Mexico irrigation works construction fund or the improvement of Rio Grande income fund; and

(b) no more than two hundred fifty thousand dollars (\$250,000) shall be allocated from the fund to any one acequia or community ditch per fiscal year;

1 protection from floods of dams, reservoirs, ditches, 2 diversions, flumes or appurtenances of acequia and community 3 ditches; provided that: 4 (a) no more than ninety percent of the 5 project cost shall be provided from the fund and an acequia or community ditch shall provide ten percent of the project costs; 6 7 and 8 (b) no more than two hundred thousand dollars (\$200,000) shall be provided from the fund to any one 9 acequia or community ditch per fiscal year; 10 (3) engineering services for approved acequia 11 12 or community ditch projects; provided that no more than three hundred thousand dollars (\$300,000) shall be expended from the 13 fund for this purpose per fiscal year; 14 (4) emergency repairs to acequia or community 15 ditch infrastructure; provided that no more than two hundred 16 fifty thousand dollars (\$250,000) shall be expended from the 17 fund for this purpose per fiscal year and no more than ten 18 thousand dollars (\$10,000) shall be provided to any one acequia 19 or community ditch for this purpose per fiscal year; and 20 low-interest loans for engineering, (5) 21 design, construction or rehabilitation of acequia or community 22 ditch projects. 23 C. be appropriated by the [state] legislature to [said] <u>the</u> construction fund. [Such] <u>The</u> fund shall be a continuing fund and shall not revert to the general fund [of the state] or to any other fund [of the state at the end of any biennium].

B. Annually, two million five hundred thousand dollars (\$2,500,000) shall be transferred from the New Mexico irrigation works construction fund to the acequia and community ditch infrastructure fund.

C. The cost of investigations and construction as authorized in Section [75-34-11 New Mexico Statutes Annotated, 1953 Compilation (being Laws 1955, Chapter 266, Section 3)] 72-14-11 NMSA 1978 shall be paid from [said] the New Mexico irrigation works construction fund and also the cost of all preliminary work on any project, and all expenses directly chargeable to such project, prior to the receipt of the proceeds of bonds, shall be paid from the construction fund. The amount of all such expenses on account of any project [or projects] and such part of the general administrative expenses of the commission and the cost of investigation [or investigations] as shall be properly chargeable, in the opinion of the commission, to such project [or projects] shall be reimbursed to the construction fund upon the receipt of the proceeds of bonds issued for such project [or projects]. No liability or obligation shall be incurred under the provisions of Sections [75-34-9 to 75-34-27 New Mexico Statutes, 1953

1 Compilation (being Laws 1955, Chapter 266, Sections 1 to 19)] 2 72-14-9 through 72-14-28 NMSA 1978 beyond the extent to which 3 the money [shall have] has been provided under the authority of 4 [this act] those sections. All public and private property 5 damaged or destroyed in carrying out the powers granted under [this act] those sections shall be restored or repaired and 6 7 placed in [their] its original condition, as nearly as 8 practicable, or adequate compensation made therefor out of 9 funds provided by [this act] those sections.

The commission shall also have authority to pay D. the cost of such investigations and construction on any project from [said] the New Mexico irrigation works construction fund when contracts in form satisfactory to it [shall] have been entered into whereby title to works [shall] have been mortgaged, deeded, assigned or transferred by the owner [thereof] to the commission, and a program for reimbursement of all amounts expended, together with operation and maintenance charges, [shall] have been agreed upon. Provided that no construction contract shall be entered into without the prior approval of the state board of finance. The commission shall also have authority to receive and accept appropriations and contributions from any source of either money or property or other things of value to be held, used and applied for the purposes [in this act] provided in Sections 72-14-9 through 72-14-28 NMSA 1978."
