I request that the following be funded:

- to the office of the state engineer

BLOOMFIELD IRRIGATION DIST DITCH IMPROVE

six hundred forty-five thousand five hundred thirty-seven dollars (\$645,537) to plan, design and construct improvements to the district irrigation ditch, including the Blanco flume, for the Bloomfield irrigation district in San Juan county

- to the department of environment

NORTH STAR DWC & MSWC FCLTY CONSTRUCT

six hundred fifty thousand dollars (\$650,000) to purchase property and to plan, design, construct, furnish, equip and improve an administrative office facility for the North Star domestic water consumers and mutual sewage works cooperative in San Juan county

NORTH STAR DWC & MSWC PH 1 WATER SYS IMPROVE

seven hundred fifty thousand dollars (\$750,000) to plan, design and construct phase 1 improvements to the North Star water system for the North Star domestic water consumers and mutual sewage works cooperative in San Juan county

NORTH STAR DWC & MSWC PIPELINE CONNECT

four hundred fifty thousand dollars (\$450,000) to plan, design and construct a regional pipeline connection to the Flora Vista water system from the North Star domestic water consumers and mutual sewage works cooperative in San Juan county

NORTH STAR DWC & MSWC SCADA SYS IMPROVE

seventy thousand dollars (\$70,000) to plan, design, construct, equip, repair and improve the supervisory control and data acquisition system for the North Star domestic water consumers and mutual sewage works cooperative in San Juan county

VALLEY WATER & SANITATION DIST WWATER PUMP STN

six hundred thousand dollars (\$600,000) to plan, design, purchase, construct and equip a wastewater pump station for the Valley water and sanitation district in San Juan county

NORTH STAR/E CULPEPPER FLATS WATER SYS SAN JUAN CO

two million dollars (\$2,000,000) to acquire rights of way and to plan, design and construct water system improvements and a water line from the North Star domestic water consumers and mutual sewage works cooperative system to the East Culpepper Flats domestic water consumers association system in San Juan county

BLANCO MDWC & MSHA WATER LINE EXTEND

five hundred ten thousand nine hundred dollars (\$510,900) to plan, design and construct a water line extension from the Blanco mutual domestic water consumers and mutual sewage works association to the Turley and San Juan and Las Vegas communities in San Juan county

FARMERS MUTUAL DITCH IMPROVE SAN JUAN CO

four million two hundred thousand dollars (\$4,200,000) to plan, design, construct and equip phase 1 improvements to the Farmers mutual ditch in San Juan county

TURLEY-MANZANARES DITCH IMPROVE SAN JUAN

thirty-five thousand dollars (\$35,000) to plan, design and construct improvements to the Turley-Manzanares community ditch in San Juan county

SAN JUAN CO MULTI USE TRAIL FLORA VISTA

five hundred thousand dollars (\$500,000) to plan, design and construct a multi-use trail, including related amenities, in the Flora Vista area in San Juan county

SAN JUAN CO RGNL FILM STUDIO CONSTRUCT

one million dollars (\$1,000,000) to acquire land for and to plan, design, construct and equip a regional film studio in San Juan county

SAN JUAN RGNL MED CTR MECH INFRA IMPROVE

one million three hundred forty-seven thousand five hundred dollars (\$1,347,500) to plan, design, construct, equip and install infrastructure improvements, including replacing the central utility plant chiller and cooling tower, for the San Juan regional medical center in Farmington in San Juan county

SAN JUAN RGNL MED CTR PEDIATRIC UNIT IMPROVE

seven hundred forty thousand three hundred two dollars (\$740,302) to plan, design, construct, renovate and equip the pediatric unit, including relocation, room expansions and bathroom facilities improvements, for the San Juan regional medical center in Farmington in San Juan county

SAN JUAN RGNL MED CTR WATER INFRA IMPROVE

five hundred fifty thousand dollars (\$550,000) to plan, design, construct, equip and install infrastructure improvements, including water pumping capacity and steam distribution system upgrades, for the San Juan regional medical center in Farmington in San Juan county

NM HWY 371/NAVAJO RTE 36 TRAFFIC SIGNAL

one million six hundred eighty-seven thousand eighty-six dollars (\$1,687,086) to plan, design, construct, purchase and install a traffic signal and related road work, including widening, at the intersection of New Mexico highway 371 and Navajo route 36 in San Juan county

SAN JUAN CO KIRTLAND SCHL WALK PATH EXTEND

five hundred thousand dollars (\$500,000) to acquire matching federal funds and to plan, design and construct an extension to the Kirtland schools walk path in San Juan county

E AZTEC ARTERIAL ROUTE CONSTRUCT SAN JUAN CO

three million five hundred thousand dollars (\$3,500,000) to plan, design and construct the east Aztec arterial route in Aztec in San Juan county

NM HWY 170 IMPROVE FARMINGTON

seven hundred fifty thousand dollars (\$750,000) to plan, design and construct improvements to New Mexico highway 170 in Farmington in San Juan county

NM HWY 64 IMPROVE FARMINGTON

one million dollars (\$1,000,000) to plan, design and construct improvements to New Mexico highway 64, including drainage, bridge and intersections, in Farmington in San Juan county
