SM114 requests that the New Mexico Municipal League and New Mexico Counties convene a working group to evaluate relocation options for the Fire Marshal Division of the Public Regulation Commission (PRC). The working group will be comprised of a representative from:

- 1. Homeland Security and Emergency Management Department
- 2. Department of Public Safety
- 3. Office of Superintendent of Insurance (OSI)
- 4. Public Regulation Commission
- 5. Fire Marshal Division of the PRC
- 6. New Mexico Fire Chief Association
- 7. Fire and emergency managers affiliate of New Mexico Counties
- 8. New Mexico State Firefighters Association
- 9. New Mexico Emergency Medical Technicians Association
- 10. New Mexico Fire Marshal's Association
- 11. Metropolitan Fire Chiefs Association
- 12. New Mexico Professional Firefighters Association

SM114 requests that the working group report its findings to the appropriate interim legislative committee by September 1, 2019.

FISCAL IMPLICATIONS
