12	JUDGE, A PROBATE JUDGE OF ANOTHER COUNTY MAY HOLD COURT IN THE
13	UNAVAILABLE JUDGE'S COUNTY; REQUIRING THE COUNTY TO PROVIDE
14	REIMBURSEMENT FOR PER DIEM AND MILEAGE.

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 34-7-11 NMSA 1978 (being Laws 1933,
18	Chapter 101, Section 1, as amended) is amended to read:
19	"34-7-11. <u>DISTRICT JUDGEPROBATE POWERS</u>
20	<u>A.</u> Whenever the probate judge [shall be] <u>is</u> absent
21	from the county [wherein he] <u>in which the probate judge</u> was
22	elected or [shall be] <u>is</u> incapacitated or <u>otherwise</u> unable to
23	attend to [his] <u>the probate judge's</u> duties [from] <u>for</u> any cause
24	[whatsoever], any district judge of [said] <u>that</u> county, or any
25	other district judge designated to hold court in [said] <u>that</u>

1	county, [for him] may do [any and] all things that could
2	otherwise be done by [said] <u>the unavailable</u> probate judge,
3	without the necessity of having the matters or proceedings
4	transferred from the docket of the probate court to the docket
5	of the district court. The fact of [such] <u>the</u> absence or
6	incapacity of the unavailable probate judge shall be recited in
7	every order of the district judge entered in accordance with
8	this [act] section.
9	B. Whenever the probate judge is absent from the
10	county in which the probate judge was elected or is
11	incapacitated or otherwise unable to attend to the probate
12	judge's duties for any cause, a probate judge of another county
13	may do all things that could otherwise be done by the
14	unavailable probate judge when designated by the unavailable
15	probate judge in accordance with the provisions of Subsection C
16	of this section or with approval by the board of county
17	commissioners, or the equivalent governing body if a different
18	form of county governance is in place, of the county of the
19	unavailable probate judge. The visiting probate judge
20	fulfilling the duties of the unavailable probate judge shall
21	hold court in the location designated in the county seat of the
22	county of the unavailable probate judge. The fact of the
23	absence or incapacity of the probate judge of the county shall
24	be recited in every order of the visiting probate judge entered
25	in accordance with this section, and the visiting judge shall

2	<u>the unavailable probate judge shall reimburse any visiting</u>
3	probate judge for per diem and mileage pursuant to the Per Diem
4	and Mileage Act.
5	C. A probate judge that is anticipating an extended
6	absence may designate whether a district judge or visiting
7	probate judge will fulfill the absent probate judge's
8	responsibilities during the judge's absence. When the probate
9	judge is incapacitated and absent or when the probate judge
10	fails to designate a judge to fulfill the judge's
11	responsibilities during an absence, the board of county
12	commissioners of the county of the unavailable and
13	incapacitated probate judge, or the equivalent governing body
14	if a different form of county governance is in place, shall
15	<u>determine whether a district judge or visiting probate judge</u>
16	will fulfill the unavailable probate judge's duties. Any
17	<u>selection of a district judge or a visiting probate judge by an</u>
18	<u>unavailable probate judge pursuant to this subsection shall</u>
19	comply with the provisions of Subsections A and B of this
20	section."
21	SECTION 2. Section 45-1-307 NMSA 1978 (being Laws 1975,
22	Chapter 257, Section 1-307) is amended to read:
23	"45-1-307. PROBATE COURTPOWERSIf for any reason the
24	probate judge is unable to act, the acts and orders [which]
