I request that the following be funded:

- to the department of environment

ISLETA PUEBLO SOLID WASTE TRANSFER STATION UPGRADE

one million dollars (\$1,000,000) to plan, design and construct upgrades to the solid waste transfer facility for the Pueblo of Isleta in Bernalillo, Tarrant and Valencia counties

ISLETA PUEBLO WELL & TANK CONSTRUCT

two million five hundred thousand dollars (\$2,500,000) to plan, design and construct water system additions, including wells and elevated water tanks, for the Pueblo of Isleta in Bernalillo, Tarrant and Valencia counties

LA MADERA MDWCA WATER TANK CONSTRUCT PH 2

one hundred one thousand four hundred twenty-nine dollars (\$101,429) to plan, design and construct phase 2 of a water storage tank replacement, including a level control system and foundation, for La Madera mutual domestic water consumers' association in Rio Arriba county

TIERRA AMARILLA LAND GRANT LAND ACQ

to acquire property in accordance with a settlement agreement reached by the Office of the New Mexico Attorney General, including to pay back any loan, excluding interest, required to meet the settlement terms that is made prior to the release of funds, in Rio Arriba County

REDINET EMBUDO FIBER OPTIC SECURITY EXPAND

twenty-four thousand nine hundred seventy dollars (\$24,970) to plan, design, and construct redinet repeater fiber optic expansions, including 911 security improvements, for governmental business operations in Embudo in Rio Arriba county
