SUMMARY

Synopsis of SHPAC Amendment

The Senate Health and Public Affairs Committee amendent to Senate Bill 99 adds a provision to allow the attorney general to require any charitable organization to submit an audit in accordance with generally accepted accounting principles prior to the initiation of civil proceedings if they have reason to believe it is in the public's interest.

Synopsis of Original Bill

Senate Bill 99 (SB99) raises the revenue threshold from \$250 thousand a year to \$750 thousand a year for tax-exempt organizations that are required to provide proof of an adequate accounting system and an annual audit prior to soliciting or receiving donations. Organizations under the threshold provide financial statements in the form of balance sheets.

SB99 also amends the Charitable Solicitations Act (CSA) by raising the revenue threshold, from

\$500 thousand to \$750 thousand, for organizations that currently are required to provide an annual audit.

SB99 also cleans up some language within the CSA to make the grammar consistent with the proposed amendments.

The effective date of this bill is January 1, 2022.

FISCAL IMPLICATIONS

The change may result in fewer audit waiver requests from the NMAG and save staff time and associated labor costs.

SIGNIFICANT ISSUES

Raising the revenue thresholds may result in fewer charities performing and reporting audits. Audits and audit reviews provide increased transparency for donors and regulators.
