21	CONCURRING THEREIN, that Joint Rule 10-1 be amended to read:

23	A. The legislative council service shall

The limitation provided in this rule does not apply to the general appropriation bill, bills to provide for the current expenses of the government and such bills as may be referred to the legislature by the governor by special message specifically setting forth the emergency or necessity requiring such legislation.

> B. If an interim committee has endorsed a bill, resolution or memorial, the legislative council service shall draft and prepare the bill, resolution or memorial for introduction in only one house.

C. The legislative council service shall draft and prepare bills, resolutions and memorials
