7	sessions, [ <del>the</del> ] <u>a</u> senator <u>who has been in close</u>

21	Santa Fe and participate by simultaneous, remote
22	electronic means and be visually present or, if
23	participating by telephone, confirm the senator's
24	presence by voice. A senator who is self-isolating
25	shall continue in self-isolation until advised by a
