BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 34-6-8 NMSA 1978 (being Laws 1968, Chapter 69, Section 11, as amended) is amended to read:

"34-6-8. JUDGES--FIFTH JUDICIAL DISTRICT.--There shall be

SECTION 2. Section 34-6-16 NMSA 1978 (being Laws 1971, Chapter 52, Section 3, as amended) is amended to read:

"34-6-16. JUDGES--THIRTEENTH JUDICIAL DISTRICT.--There shall be [eight] nine district judges in the thirteenth judicial district."

HJC→SECTION 3. TEMPORARY PROVISION--DISTRICT JUDGES--APPOINTMENTS.--The additional district judgeships provided for in this act shall be filled by appointment of the governor pursuant to Article 6, Section 36 of the constitution of New Mexico.←HJC
