| 16 | SECTION 1. Section 31-18-15.3 NMSA 1978 (being Laws 1993, |
| 17 | Chapter 77, Section 3) is amended to read: |
| 18 | "31-18-15.3. SERIOUS YOUTHFUL OFFENDERDISPOSITION |
| 19 | A. An alleged serious youthful offender may be |
| 20 | detained in any of the following places, prior to arraignment |
| 21 | in metropolitan, magistrate or district court: |
| 22 | (1) a detention facility for delinquent |
| 23 | children, licensed by the children, youth and families |

When an alleged serious youthful offender is 6 Β. 7 detained in a juvenile detention facility prior to trial, the time spent in the juvenile detention facility shall count 8 9 [towards] toward completion of any sentence imposed. C. At arraignment, when a metropolitan or district 10 court judge or a magistrate determines that an alleged serious 11 12 youthful offender should remain in custody, the alleged serious youthful offender may be detained in an adult or juvenile 13 detention facility, subject to the facility's accreditation and 14 the provisions of applicable federal law. 15 When an alleged serious youthful offender is D. 16 found guilty of first degree murder, the court shall sentence 17 the offender pursuant to the provisions of the Criminal 18 Sentencing Act; provided that a child upon whom an adult 19 sentence is invoked shall not be sentenced to life imprisonment 20 without possibility of release or parole. The court may 21 sentence the offender to less than, but not exceeding, the 22 mandatory term for an adult. The determination of guilt 23 becomes a conviction for purposes of the Criminal Sentencing 24 25 Act.

Ε. Prior to the sentencing of an alleged serious youthful offender who is convicted of first degree murder, adult probation services shall prepare a presentence report and submit the report to the court and the parties five days prior to the sentencing hearing.

F. When the alleged serious youthful offender is convicted of a lesser offense than first degree murder, the court shall provide for disposition of the offender pursuant to 8 the provisions of Section [32-2-19 or 32-2-20] <u>32A-2-19 or</u> 32A-2-20 NMSA 1978. When an offender is adjudicated as a delinquent child, the conviction shall not be used as a 12 conviction for purposes of the Criminal Sentencing Act."

SECTION 2. Section 31-21-10 NMSA 1978 (being Laws 1980, Chapter 28, Section 1, as amended) is amended to read:

> "31-21-10. PAROLE AUTHORITY AND PROCEDURE .--

Except as provided in Section 31-21-10.2 NMSA Α. 1978, an inmate of an institution who was sentenced to life imprisonment becomes eligible for a parole hearing after the inmate has served thirty years of the sentence. Before ordering the parole of an inmate sentenced to life imprisonment, the board shall:

1 the guidance and supervision of the board.

C. An inmate of an institution who was sentenced to life imprisonment without possibility of release or parole is not eligible for parole and shall remain incarcerated for the entirety of the inmate's natural life.

D. Except for certain sex offenders as provided in Section 31-21-10.1 NMSA 1978, an inmate who was convicted of a first, second or third degree felony and who has served the sentence of imprisonment imposed by the court in an institution designated by the corrections department shall be required to undergo a two-year period of parole. An inmate who was convicted of a fourth degree felony and who has served the sentence of imprisonment imposed by the court in an institution designated by the corrections department shall be required to undergo a one-year period of parole. During the period of parole, the person shall be under the guidance and supervision of the board.

E. Every person while on parole shall remain in the legal custody of the institution from which the person was released, but shall be subject to the orders of the board. The board shall furnish to each inmate as a prerequisite to release under its supervision a written statement of the conditions of parole that shall be accepted and agreed to by the inmate as evidenced by the inmate's signature affixed to a duplicate copy to be retained in the files of the board. 1 require as a prerequisite to release the submission and 2 approval of a parole plan. If an inmate refuses to affix the 3 inmate's signature to the written statement of the conditions of parole or does not have an approved parole plan, the inmate 4 5 shall not be released and shall remain in the custody of the institution in which the inmate has served the inmate's 6 7 sentence, excepting parole, until such time as the period of 8 parole the inmate was required to serve, less meritorious 9 deductions, if any, expires, at which time the inmate shall be released from that institution without parole, or until such 10 time that the inmate evidences acceptance and agreement to the 11 12 conditions of parole as required or receives approval for the inmate's parole plan or both. Time served from the date that 13 14 an inmate refuses to accept and agree to the conditions of parole or fails to receive approval for the inmate's parole 15 plan shall reduce the period, if any, to be served under parole 16 at a later date. If the district court has ordered that the 17 inmate make restitution to a victim as provided in Section 18 19 31-17-1 NMSA 1978, the board shall include restitution as a 20 condition of parole. The board shall also personally apprise the inmate of the conditions of parole and the inmate's duties 21 relating thereto. 22

F. When a person on parole has performed the obligations of the person's release for the period of parole provided in this section, the board shall make a final order of .221204.1 - 6 -

discharge and issue the person a certificate of discharge.

G. Pursuant to the provisions of Section 31-18-15 NMSA 1978, the board shall require the inmate as a condition of parole:

to pay the actual costs of parole services (1)to the adult probation and parole division of the corrections department for deposit to the corrections department intensive supervision fund not exceeding one thousand eight hundred dollars (\$1,800) annually to be paid in monthly installments of not less than twenty-five dollars (\$25.00) and not more than one hundred fifty dollars (\$150), as set by the appropriate district supervisor of the adult probation and parole division, based upon the financial circumstances of the defendant. The defendant's payment of the supervised parole costs shall not be waived unless the board holds an evidentiary hearing and finds that the defendant is unable to pay the costs. If the board waives the defendant's payment of the supervised parole costs and the defendant's financial circumstances subsequently change so that the defendant is able to pay the costs, the appropriate district supervisor of the adult probation and parole division shall advise the board and the board shall hold an evidentiary hearing to determine whether the waiver should be rescinded; and

(2) to reimburse a law enforcement agency or local crime stopper program for the amount of any reward paid .221204.1

H. The provisions of this section shall apply to all inmates except geriatric, permanently incapacitated and terminally ill inmates eligible for the medical and geriatric parole program as provided by the Parole Board Act."

SECTION 3. A new section of the Probation and Parole Act, Section 31-21-10.2 NMSA 1978, is enacted to read:

"31-21-10.2. [<u>NEW MATERIAL</u>] PAROLE FOR CHILDREN SENTENCED AS ADULTS.--

A. A serious youthful offender sentenced under Section 31-18-15.3 NMSA 1978 or a youthful offender sentenced as an adult under Section 32A-2-20 NMSA 1978 shall be entitled to a parole hearing after serving fifteen years of the offender's sentence, unless the offender is subject to earlier eligibility for parole pursuant to another provision of law. The parole hearing shall occur whether the offender is serving sentences for multiple crimes concurrently or consecutively.

B. If parole is denied, the offender shall be entitled to a parole hearing not less than every five years thereafter, unless the offender is subject to earlier eligibility for parole pursuant to any other provision of law.

C. During a parole eligibility hearing involving a person subject to a parole hearing pursuant to this section, the board shall take into consideration, in addition to other .221204.1

The board shall annually conduct a review of all offenders currently serving an adult sentence for an offense 13 14 committed as a child to ensure that parole eligibility hearings required pursuant to this section are timely conducted." 15 Section 32A-2-20 NMSA 1978 (being Laws 1993, SECTION 4. 16 Chapter 77, Section 49, as amended) is amended to read: 17 "32A-2-20. DISPOSITION OF A YOUTHFUL OFFENDER. --18 19 Α. The court has the discretion to invoke either an 20 adult sentence or juvenile sanctions on a youthful offender. The children's court attorney shall file a notice of intent to 21 invoke an adult sentence within ten working days of the filing 22 of the petition; provided that the court may extend the time 23 for filing of the notice of intent to invoke an adult sentence, 24 for good cause shown, prior to the adjudicatory hearing. preliminary hearing by the court or a hearing before a grand jury shall be held, within ten days after the filing of the intent to invoke an adult sentence, to determine whether probable cause exists to support the allegations contained in the petition.

B. If the children's court attorney has filed a notice of intent to invoke an adult sentence and the child is adjudicated as a youthful offender, the court shall make the following findings in order to invoke an adult sentence:

(1) the child is not amenable to treatment or rehabilitation as a child in available facilities; and

(2) the child is not eligible for commitment to an institution for children with developmental disabilities or mental disorders.

C. In making the findings set forth in Subsection B of this section, the judge shall consider the following factors:

the seriousness of the alleged offense;

(2) whether the alleged offense was committedin an aggressive, violent, premeditated or willful manner;

(3) whether a firearm was used to commit the alleged offense;

(4) whether the alleged offense was against persons or against property, greater weight being given to offenses against persons, especially if personal injury .221204.1

alleged in the petition. A child upon whom an adult sentence is invoked shall not be sentenced to life imprisonment without the possibility of release or parole. 3

If a juvenile disposition is appropriate, the F. court shall follow the provisions set forth in Section 32A-2-19 NMSA 1978. A youthful offender may be subject to extended commitment in the care of the department until the age of twenty-one, pursuant to the provisions of Section 32A-2-23 NMSA 1978.

A child fourteen years of age or older, charged G. with first degree murder, but not convicted of first degree murder and found to have committed a youthful offender offense as set forth in Subsection [+] J of Section 32A-2-3 NMSA 1978, is subject to the dispositions set forth in this section.

н. A child fourteen years of age or older charged with first degree murder, but found to have committed a delinquent act that is neither first degree murder nor a youthful offender offense as set forth in Subsection $[\pm]$ J of Section 32A-2-3 NMSA 1978, shall be adjudicated as a delinquent subject to the dispositions set forth in Section 32A-2-19 NMSA 1978."

SECTION 5. APPLICABILITY.--The provisions of this act apply retroactively to all offenders currently serving an adult sentence for an offense committed as a child.
