11. On page 7, line 22, strike "recipients'" and insert in lieu thereof "their".
12. On page 8, line 7, strike "address any challenges accessing" and insert in lieu thereof "access".

18. On page 24, lines 5 through 10, strike Section 17 in its entirety.
