## AN ACT

RELATING TO EMPLOYMENT; INCLUDING VETERINARIANS IN THE DEFINITION OF "HEALTH CARE PRACTITIONER" FOR THE PURPOSE OF MAKING CERTAIN PROVISIONS IN HEALTH CARE PRACTITIONER AGREEMENTS VOID, UNENFORCEABLE AND AGAINST PUBLIC POLICY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 24-11-1 NMSA 1978 (being Laws 2015, Chapter 96, Section 1, as amended) is amended to read:

"24-11-1. DEFINITIONS.--As used in Chapter 24, Article 11 NMSA 1978:

- "agreement" means a written contract to which Α. a health care practitioner is a party; and
  - "health care practitioner" means:
    - (1) a dentist;
    - (2) an osteopathic physician;
