4 In accordance with the policy established in the Α. 5 New Mexico Telecommunications Act, the commission shall, by its 6 own motion or upon petition by any interested party, [hold 7 hearings to] determine if [any public telecommunications 8 service] a wire center serving area is subject to effective 9 competition [in the relevant market area]. When the commission 10 has made a determination that a [service or part of a service] 11 wire center serving area is subject to effective competition, 12 the commission shall, consistent with the purposes of the New 13 Mexico Telecommunications Act, [modify, reduce or] eliminate 14 rules, regulations and other requirements applicable to the 15 provision of [such service, including the fixing and 16 determining of specific rates, tariffs or fares for the 17 service] telecommunications services within that wire center 18 serving area. 5 No provider of public telecommunications service D. 6 may use current revenues earned or expenses incurred in 7 conjunction with any noncompetitive service to subsidize 8 competitive public telecommunications services. In order to 9 avoid cross-subsidization of competitive services by 10 noncompetitive telecommunications services, prices or rates 11 charged for a competitive telecommunications service shall 12 cover the cost for the provision of the service consistent with 13 the provisions of Subsection G of Section 63-9A-8.1 NMSA 1978. 14 In any proceeding held pursuant to this section, the party 15 claiming that the price for a competitive telecommunications 16 service does not cover the cost shall bear the burden of 17 proving that the prices charged for competitive 18 telecommunications services do not cover cost; provided, 19 however, that the commission may require the telecommunications 20 company against whom the complaint is filed to submit a cost 21 study for the service that is the subject of the complaint as 22 part of its examination and determination of the complaint.
