11 RELATING TO CRIME; PROVIDING NO TIME LIMITATIONS FOR COMMENCING
12 A PROSECUTION FOR CRIMINAL SEXUAL PENETRATION OF A MINOR AND
13 CRIMINAL SEXUAL CONTACT OF A MINOR; PROVIDING A FIFTEEN-YEAR
14 TIME LIMITATION FOR COMMENCING A PROSECUTION FOR CRIMINAL
15 SEXUAL PENETRATION IN THE SECOND DEGREE.

17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

18 SECTION 1. Section 30-1-8 NMSA 1978 (being Laws 1963,
19 Chapter 303, Section 1-8, as amended) is amended to read:

20 "30-1-8. TIME LIMITATIONS FOR COMMENCING PROSECUTION.--A
21 person shall not be prosecuted, tried or punished in any court
22 of this state unless the indictment is found or information or
23 complaint is filed within the time as provided:

24 A. for a second degree felony, within six years
25 from the time the crime was committed;

1 B. for a third or fourth degree felony, within five
2 years from the time the crime was committed;

3 C. for a misdemeanor, within two years from the
4 time the crime was committed;

5 D. for a petty misdemeanor, within one year from
6 the time the crime was committed;

7 E. for any crime against or violation of Section
8 51-1-38 NMSA 1978, within three years from the time the crime
9 was committed;

10 F. for a felony pursuant to Section 7-1-71.3,
11 7-1-72 or 7-1-73 NMSA 1978, within five years from the time the
12 crime was committed; provided that for a series of crimes
13 involving multiple filing periods within one calendar year, the
14 limitation shall begin to run on December 31 of the year in
15 which the crimes occurred;

16 G. for an identity theft crime pursuant to Section
17 30-16-24.1 NMSA 1978, within five years from the time the crime
18 was discovered;

19 H. for any crime not contained in the Criminal Code
20 or where a limitation is not otherwise provided for, within
21 three years from the time the crime was committed; ~~and~~

22 I. for a capital felony, a first degree violent
23 felony or second degree murder pursuant to Subsection B of
24 Section 30-2-1 NMSA 1978, no limitation period shall exist and
25 prosecution for these crimes may commence at any time after the

1 occurrence of the crime;
2 J. for a crime against a child under eighteen years
3 of age in violation of Subsection E of Section 30-9-11 NMSA
4 1978 or Subsection B of Section 30-9-13 NMSA 1978, no
5 limitation shall exist and prosecution of these crimes may
6 commence at any time after the occurrence of the crime; and
7 K. for a crime of criminal sexual penetration in
8 the second degree pursuant to Subsection E of Section 30-9-11
9 NMSA 1978 against an adult, within fifteen years from the time
10 the crime was committed."
