18	"53-19-8. ARTICLES OF ORGANIZATIONThe articles of
19	organization shall set forth:
20	A. a name for the limited liability company that
21	satisfies the requirements of Section 53-19-3 NMSA 1978;
22	B. the street address of the initial registered
23	office and the name of the initial registered agent at that
24	address and the street address of the limited liability
25	company's current principal place of business, if different

The articles of organization of a limited 20 liability company are amended when articles of amendment are 21 filed with the secretary of state or at any later date or time 22 specified in the articles of amendment if there has been 23 substantial compliance with the requirements of the Limited 24 Liability Company Act. 1 (1) the name of the limited liability company 2 and, if different, include any name under which it proposes to 3 transact business in New Mexico; 4 the date that the articles of organization (2) 5 were filed; and the amendments of the articles of 6 (3) 7 organization. 8 The articles of organization may be amended in Β. 9 any respect desired, so long as the articles of organization, 10 as amended, contain only provisions that may be lawfully 11 contained in articles of organization at the time of making the 12 amendment. 13 The articles of organization shall be amended to C. 14 reflect any change in the name of the limited liability 15 company; the membership of the limited liability company, which 16 shall include the name and address of each member not already 17 provided to the secretary of state; the latest date on which 18 the limited liability company is to dissolve; or whether the 19 limited liability company is to be managed by members or 20 managers. 21 Articles of organization may be restated at any D. 22 time. Restated articles of organization shall be filed with 23 the secretary of state and shall be designated as such in the 24
