17	SECTION 1. Section 6-29-1 NMSA 1978 (being Laws 2005,

D. authorize grants from the federal infrastructure matching fund to a tribal applicant to meet match requirements for federal grants for infrastructure projects in New Mexico."

SECTION 3. A new section of the Tribal Infrastructure Act is enacted to read:

"[<u>NEW MATERIAL</u>] FEDERAL INFRASTRUCTURE MATCHING FUND--CREATED--PURPOSE--APPROVALS--EXPENDITURE LIMITATION.--

A. The "federal infrastructure matching fund" is created as a nonreverting fund in the state treasury. The fund consists of appropriations, income from investment of the fund, gifts, grants and donations. The fund shall be administered by the department of finance and administration. Money in the fund is subject to appropriation by the legislature to provide a funding source for tribal governments to meet match requirements for federal tribal infrastructure grants for projects wholly within New Mexico. The total amount that may be expended from the fund per year is ten million dollars (\$10,000,000).

B. Tribal governments may submit applications on forms provided by the board. The application shall include project approval by the state fiscal agent. The board, in consultation with tribal governments, shall specify by rule application requirements, including a maximum amount allowable from the fund for any one grant based on the number of applications submitted."
