AN ACT

RELATING TO MUNICIPALITIES; ALLOWING A COMMISSIONER OF A HOUSING AUTHORITY TO HOLD OFFICE OR EMPLOYMENT FOR THE SAME CITY FOR WHICH THE AUTHORITY IS CREATED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 3-45-5 NMSA 1978 (being Laws 1965, Chapter 300, Section 14-46-5, as amended) is amended to read:

"3-45-5. CREATION OF AUTHORITY.--

A. Every city, in addition to other powers conferred by the Municipal Housing Law, shall have power and is authorized, by proper resolution of its governing body, to create an authority to be known as the "housing authority" of the city as a public body politic and corporate separate from the city. The city may delegate to the authority the power to construct, maintain, operate and manage any housing project or affordable housing programs of the city and may delegate to the authority any or all of the powers conferred on the city by the Municipal Housing Law.

B. When the governing body of a city adopts a resolution pursuant to Subsection A of this section:

(1) the mayor shall appoint three, five or seven persons as commissioners of the authority as follows:

(a) at least three commissioners if the municipality is a village, town or county that does not

1 contain a metropolitan statistical area as defined by the
2 United States census; or

3 (b) at least five but no more than
4 seven commissioners if the municipality is a city or a county
5 that contains a metropolitan statistical area as defined by
6 the United States census; and

7 (2) the commissioners who are first
8 appointed shall be designated to serve staggered terms of one
9 to five years from the date of their appointment, depending
10 on the size of the authority. Thereafter, commissioners
11 shall be appointed for a term of office of five years, except
12 that all vacancies shall be filled for the unexpired term. A
13 commissioner shall hold office until a successor has been
14 appointed and has qualified, unless sooner removed according
15 to law. A commissioner may serve two or more successive
16 terms of office. A certificate of the appointment or
17 reappointment of any commissioner shall be filed with the
18 clerk, and the certificate shall be conclusive evidence of
19 the due and proper appointment of the commissioner. A
20 commissioner shall receive no compensation for services for
21 the authority in any capacity, but shall be entitled to the
22 necessary expenses, including traveling expenses, incurred in
23 the discharge of duties.

24 C. Two or more cities joined together pursuant to
25 Subsection B of Section 3-45-4 NMSA 1978 shall establish

1 their commissioners in accordance with Subsection B of this
2 section, except that each city shall have equitable
3 representation on the commission. The commissioners
4 representing each city shall be appointed by the mayor of the
5 city.

6 D. Any powers delegated by a city to an authority
7 shall be vested in the commissioners of the authority in
8 office from time to time. A majority of commissioners shall
9 constitute a quorum of the authority for the purpose of
10 conducting its business and exercising its powers and for all
11 other purposes. Action may be taken by the authority upon a
12 vote of a majority of the commissioners present. The
13 commission shall organize itself at its annual meeting each
14 even-numbered year. Any city creating a housing authority may
15 authorize the authority to employ a secretary, who shall be
16 executive director and who shall be removable only for cause.
17 With the delegated authority from the commission, the
18 executive director may hire or terminate, according to the
19 procurement and personnel policies and procedures of the
20 authority, technical experts and such other officers,
21 attorneys, agents and employees, permanent and temporary, as
22 the authority may require; determine their qualifications,
23 duties and compensation; and delegate to one or more of them
24 such powers or duties as the authority may deem proper."_____
