11	PROPOSING AN AMENDMENT TO ARTICLE 8, SECTION 5 OF THE
12	CONSTITUTION OF NEW MEXICO TO INCREASE A PROPERTY TAX EXEMPTION

16	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. It is proposed to amend Article 8, Section 5
18	of the constitution of New Mexico to read:
19	"A. The legislature shall exempt from taxation the
20	property of each head of the family in the amount of two
21	thousand dollars (\$2,000).
22	<u>B.</u> The legislature shall [ <del>also</del> ] exempt from
23	taxation the property, including the community or joint
24	property of [ <del>husband and wife</del> ] <u>married individuals</u> , of every
25	honorably discharged member of the armed forces of the United

1 States and the widow or widower of every such honorably 2 discharged member of the armed forces of the United States, in the sum of [three thousand dollars (\$3,000) in 2004; three 3 4 thousand five hundred dollars (\$3,500) in 2005; and]: 5 (1) in 2006 and in each year through 2023, four thousand dollars (\$4,000); 6 (2) in [<del>2006</del>] <u>2024, ten thousand doll</u>ars 7 8 (\$10,000); and 9 (3) in 2025 and each subsequent year, 10 [Provided, that] the amount provided in Paragraph (2) of this 11 subsection, adjusted for inflation. 12 C. In every case where exemption is claimed on the 13 ground of the claimant's having served with the armed forces of 14 the United States [as aforesaid] pursuant to Subsection B of 15 this section, the burden of proving actual and bona fide 16 ownership of such property upon which exemption is claimed 17 shall be upon the claimant." 18 SECTION 2. The amendment proposed by this resolution 19 shall be submitted to the people for their approval or 20 rejection at the next general election or at any special 21 election prior to that date that may be called for that 22 purpose. 23 - 2 -24 25
