BILL SUMMARY

Synopsis: S-238 does not have a fiscal impact for the RECs in general at the current time; if the Public School Code does change then the participating REC and Coordinating Council would have a a fiscal obligation to repay the revenue bond.

FISCAL IMPLICATIONS

Over the last 40 years the RECs in NM have grown and now do a substantial amount of work to support public education in 78% of the school districts across the state. This work includes professional development in all areas of education. They also are now being utilized for statewide efforts on behalf of the New Mexico Public Education Department. As these needs have grown so has the need for adequate, reliable, and quality facilities to support the work the RECs are being expected to perform. SB 238 addresses a significant financial arrangement and allows the RECs in NM under appropriate oversight and regulation to issue revenue bonds. The ability to do this would be beneficial to all RECs in the future as these needs continue to grow. Other state agencies and municipalities already have the ability to do this. Granting the RECs the ability to issue their own Revenue Bonds is a positive step in supporting the increasingly important role they provide in support of education in New Mexico.
