BILL SUMMARY

Synopsis: This Bill will create, staff and fund a task force that will study the current Agency of the New Mexico Office of African American Affairs (OAAA) which currently addresses the needs of New Mexican African American children, families and communities. This agency was originally initiated under a study by the Office of Cultural Affairs and is now focused on strengthening quality and awareness of health, education, history and economics of African Americans. The Office is currently attached administratively to HCA, is statutorily under the Human Rights code and affiliated for some purposes with the Martin Luther King, Jr. Commission.

FISCAL IMPLICATIONS

An appropriation of \$100,000 is made by the bill for the task force and study.

The Task Force will evaluate and make a final report to the Governor regarding elevating the OAAA to Department status, unifying the OAAA with the Martin Luther King, Jr. commission and other areas of concern
