#### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

<u>Synopsis:</u> HB53 requires the Taxation and Revenue Department (TRD), Motor Vehicle Division to apply for a license to use the Smokey Bear image and name and to issue a Smokey Bear fire prevention special registration plate. HB53 makes an appropriation to TRD to issue these plates, and provides for licensing fee revenue distribution to the Energy, Minerals and Natural Resources Department (EMNRD) for forest fire prevention in the amount of \$12.00 per plate sold.

#### FISCAL IMPLICATIONS

EMNRD will receive a portion of the initial registration fee for the special license plate and the entire portion of subsequent renewal fees after payment of licensing fees by TRD. The fees are to be utilized for forest fire prevention, and would therefore devolve to the Forestry division.

As it is unclear how many plates will be sold, it is impossible to define how much Forestry would actually receive. However, whatever number of plates do end up being sold, the additional revenue is likely to have a negligible, but positive, impact on the Forestry division.

#### SIGNIFICANT ISSUES

None.

#### **PERFORMANCE IMPLICATIONS**

HB 53 may enhance performance by providing additional revenue for forest fire prevention activities and messaging conducted by the EMNRD Forestry Division, depending on the amount of Smokey Bear license plates which are sold.
