SECTION III: NARRATIVE

BILL SUMMARY

This bill amends the Criminal Sentencing Act to reinstate the death penalty by lethal injection for specific capital felony crimes when aggravating circumstances are determined by a jury after an initial finding of guilt and during a separate hearing wherein the jury must decide whether to sentence the defendant to life imprisonment; life imprisonment without the possibility of release or parole; or death.

Along with some modernization and wording updates, this bill's language is pulled from former, rescinded laws predating the 2009 abolishment of the death penalty. See partial and wholly repealed Sections 31-18-14; 31-18-23; 31-20A-2; 31-20A-2.1; 31-20A-3; 31-20A-4; 31-20A-5; and 31-20A-6; 31-14-1 through 31-14-16, NMSA 1978.

The noted changes to the former death penalty statutes in this bill are:

- 1) a distinction of aggravating circumstances to be considered as punishable by death or life imprisonment without the possibility of parole by the jury upon conviction. These updates include removing the murder of a peace officer and the murder of an employee or contractor of a penal institution from the list of aggravating circumstances to be considered by the jury for imposition of a death sentence but adding these crimes along with victims under the age of eighteen years and attempted murder of a peace officer to the aggravated circumstances to be considered by the jury for imposition of a sentence of life imprisonment without the possibility of parole;
- 2) the addition of a requirement that the judge informs the jury at the capital sentencing hearing that the sentence of life imprisonment means the defendant shall serve thirty years before the defendant becomes eligible for a parole hearing; and
 - 3) appropriations made to the NMCD and the AOC to cover costs associated with the bill.

It is anticipated that New Mexico State Police Officers would have increased time in court testifying if House Bill 77 is signed into law. The increased overtime cost is projected to be minimal and can be absorbed by existing Operating Budget.
