### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis: HB 107 bill amends the Medical Malpractice Act to lower the maximum recoverable amount against a hospital or hospital-controlled outpatient facility. This bill does not impose a cap on actual medical expenses, which are currently unlimited.

#### FISCAL IMPLICATIONS

The Office of Superintendent of Insurance is a custodian for the Patient Compensation Fund, and releases funds in accordance with the law and applicable court orders. The legislation would not have an impact on the Patient Compensation Fund.

#### **SIGNIFICANT ISSUES**

HB 107 would significantly reduce the liability of medical malpractice claims for hospitals and hospital-controlled outpatient facilities. It is unclear if the proposed amendments are intended to apply to pending litigation.

The nature of medical malpractice claims means that many cases where injuries and deaths occurred in 2022 and onwards would be pending at the time this legislation goes into effect. Clarity will be needed to ascertain if the lower recovery amounts apply to pending litigation, or only to newly filed cases.

### PERFORMANCE IMPLICATIONS

In enacted, HB 107 would not have any performance implications on the administration of the Patient Compensation Fund.

#### ADMINISTRATIVE IMPLICATIONS

The lack of clarity regarding effective date could lead to a rush to file legal cases before the January 1, 2025 effective date, in order to remain eligible for the higher recovery amounts.
