### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

The bill impacts public libraries, defined as a library that submits an annual library survey to the state librarian. It requires libraries to:

- a) Adopt the American Library Association's (ALA) Library Bill of Rights; or
- b) Adopt a written policy that prohibits banning library materials.

Public libraries failing to do so are ineligible to receive state funds.

The bill prohibits political subdivisions of the state from reducing funding to a public library for complying with these requirements.

It does not prohibit the right of individuals to challenge library materials as may be established in individual library collection policies.

#### ADMINISTRATIVE IMPLICATIONS

NM Administrative Code (NMAC) requires state-funded libraries to submit collection development policies every five years. Passage of this bill will require the state library to amend the NMAC related to such policies to include adoption of the American Library Association's Library Bill of Rights, or a policy prohibiting banning of library materials, and a process for individuals to challenge library materials. Affected public libraries will be required to submit updated compliant policies within 1 year of the law taking effect.

### **TECHNICAL ISSUES**

### **OTHER SUBSTANTIVE ISSUES**

Section 1A(1) provides for public libraries to adopt the <u>ALA's Library Bill of Rights</u> (LBR) to comply with the bill. As an independent organization, ALA is at liberty to change the LBR at its sole discretion. Therefore, possible future changes to the LBR could affect the legislative intent of the bill going forward. Removing adoption of the LBR in favor of the individual library policy allowed under section 1A(2) will ensure future legislative intent.

Section 1(A)2 may contain ambiguous language. Clarification should be considered to ensure legislative intent is captured correctly. The LBR is clear in its two-fold prohibition against the banning of books based on 1) partisan or doctrinal disapproval of the content of the library material; **and** 2) the author's race, nationality, gender identity, sexual orientation or political or religious views. As drafted, this same distinction is unclear in Section 1(A)2.

The bill's definition of "ban" could cause confusion as there are several legitimate reasons for a book to be removed from a library, including due to condition, age, and outdated content.

# WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

Public libraries subject to the banning of books will continue to receive state funding.

### **AMENDMENTS**

Page 1, lines 17 to 25 and page 2 lines 1 to 5 amend to read:

- "A. A public library shall not be eligible to receive state funds unless the library:
- (1) adopts and complies with the American library association's library bill of rights, including the requirement that library materials not be proscribed or removed because of partisan or doctrinal disapproval or the author's race, nationality, gender identity, sexual orientation or political or religious views; or
- (2) adopts a written policy prohibiting the practice of banning books or other library materials within the library or library system on the basis of partisan or doctrinal disapproval of the material's content or the author's race, nationality, gender identity, sexual orientation or political or religious views pursuant to rules promulgated by the state librarian."

Page 2, lines 15 to 16, amend to read:

"ban' means the act of removing or prohibiting the addition of materials from a public library on the basis of partisan or doctrinal disapproval of the material's content or the author's race, nationality, gender identity, sexual orientation or political or religious views."
