#### **BILL SUMMARY**

This bill proposes to add undocumented persons to the list of certain persons prohibited under state law from receiving, transporting, or possessing a firearm or destructive device. As defined in the bill, an undocumented person is an individual not legally present in the United States.

### FISCAL IMPLICATIONS

There are no additional fiscal implications to DPS.

#### SIGNIFICANT ISSUES

Federal law defines an individual's legal status regarding immigration matters and only federal courts may make findings that an individual is not legally present in the United States. Crucially, this bill would require the investigating law enforcement agency to determine whether an individual is documented or undocumented and, therefore, legally or not legally present in the United States.
