BILL SUMMARY

Synopsis: HB 208 enacts the "Trade Education Assistance Act". HB 208 proposes to appropriate \$100,000,000 from the general fund to the Trade Education Assistance fund (created within HB 208) in FY25 and subsequent years for the purpose of providing stipends to students who are participating in trade education programs approved by the Higher Education Department (HED). A trade education program is a program approved by HED to train individuals to qualify for licenses or certificates of competence issues pursuant to the Construction Industries Licensing Act. An individual may be awarded a stipend of up to \$30,000 per calendar year.

FISCAL IMPLICATIONS

There should be no significant fiscal implications for the University of New Mexico (UNM) Valencia campus because the established stipends would be awarded by the Higher Education Department.

SIGNIFICANT ISSUES

UNM-Valencia currently has fewer than five programs that would qualify under the new program. There would be no significant issues for our campus. Most of our students receive financial aid from other sources; these stipends would further enable students to succeed in their education by providing economic support for various areas of their lives.
