BILL SUMMARY

Synopsis: HB 254 would direct NM CYFD to apply for and use the federal benefits owed to a child in state foster care custody for that child's use and benefit.

Section 3 requires NM CYFD to apply for the federal benefits. (An example of these federal benefits are "Supplemental Security Income" benefits under Title XVI of the Social Security Administration Act.) The NM CYFD shall be the party managing the receipt of these benefits, unless NM CYFD can identify another child's representative, such as an attorney, custodian, guardian, guardian ad litem or Indian tribe, to serve in this role.

Section 4 requires NM CYFD to hold onto the federal benefits in an account and use them in the "child's best interest."

Section 5 prohibits NM CYFD from using the federal benefits "to pay for or reimburse the department for any of the costs of the child's care."

Section 6 requires NM CYFD to release the balance of the funds to the child when the child leaves state foster care custody.

In 2023, CYFD implemented the proposed statutory directives through a written directive. See Albuquerque Journal, "Unprecedented': New Mexico foster children will now be allowed to keep federal benefits owed to them" (11/8/23). The requirements of the directive are set to expire in March 2024. Adoption of HB 254 will ensured current practice continues and is insulated from potential legal challenge to CYFD's authority to implement the requirements through a directive.
