#### **BILL SUMMARY**

<u>Synopsis</u>: House Bill 254 (HB254) requires the Children, Youth and Families Department (CYFD) to identify if the children in its custody are eligible for federal benefits. HB254 requires the CYFD to apply for the federal benefits either as the child's representative payee or determine an appropriate alternative. HB254 sets forth CYFD's obligations when acting as the child's representative payee; prohibiting the use of federal funds for the use of the child's care, sets forth provisions for the release of federal benefits provided to the children in legal custody of the state.
