Synopsis: Synopsis: HB 302 provides exemption from state licensing requirements for child care programs or facilities licensed or certified by the US department of defense or united states coast guard; amends the definition of a uniformed-service voter to include a member of the space force; amends the definition of the resident tuition for veterans of the armed forces to include a member of the space force and space force reserve; amends the human right act to include the definition of services and military status; amends the unlawful discriminatory practice to include military status as a qualifier; amends the deployed parents custody and visitation act to include a member of the space force under the definition of uniform-service; amends the uniform probate code to include a member of the space force; and amends the citation reference in the registration by military personnel.
