SECTION III: NARRATIVE

BILL SUMMARY

Synopsis: HB 310 amends the Tobacco Products Act ("the Act") making employees, of licensees, liable for the violation of knowingly selling a tobacco product to a minor.

- Currently, the Act allows the Alcoholic Beverage Control Division of the Regulation and Licensing Department (ABC) to suspend or revoke a license of a licensee, require the use of identification verification software, or impose an administrative penalty against a licensee up to \$10,000 if ABC finds that the licensee, an employee of the licensee, or a contractor acting on behalf of the licensee has violated a provision of the Act.
- In addition to penalties currently allowed to be imposed by ABC, HB 310 will allow ABC to administer a penalty upon an employee who knowingly sells a tobacco product to a minor.
 - The penalty for a first offense of knowingly selling a tobacco product to a minor will be in an amount not to exceed \$100.
 - The penalty for subsequent violations will be in an amount not to exceed \$500.
- HB 310 does not contain an effective date.

FISCAL IMPLICATIONS

- In the 2023 calendar year a total of seventy-two (72) citations for sales to a minor were received by ABC. Fiscal year citation numbers should track similarly with only minor differences.
 - o Barring any significant change to this number, they would have been accompanied by a maximum of seventy-two (72) citations issued to the employee as well.
 - This would result in an additional \$7,200 collected by the Regulation and Licensing Department (RLD) in penalties.

SIGNIFICANT ISSUES

- HB 310 expressly indicates that an administrative penalty may only be imposed upon an employee of a licensee for knowingly selling a tobacco product to a minor.
 - o This may create instances where the employee sells a tobacco product to a minor without knowing that the customer is a minor.
 - o The licensee will remain liable for the violation of selling to a minor, as the Act

makes it a strict liability offense for the licensee.

- The Act does not require employees to get any type of permit, or certification, to sell tobacco products.
 - O Because ABC does not gather information personal identifying/contact on employees of licensees or perform sales of tobacco, the RLD/ABC will not have contact information for the individuals it is trying to impose the penalty, unless the citations include a valid mailing address and not just the address listed on a person's identification card or driver's license.
 - Additionally, due to the lack of possible revocation of a permit or certification, there may be little incentive for individuals who have been found to have knowingly sold tobacco to a minor to actually pay an administrative penalty if imposed.
