#### **BILL SUMMARY**

Proposes to amend Articles 4 and 10 of the state constitution to create a citizen commission on legislative salaries to establish, adjust and limit the salaries of member of the legislature.

The citizen commission on legislative salaries shall review, research and consider salaries for the members of the legislature and adopt a final report on its determination to establish, adjust or limit those salaries and shall file that report with the secretary of state on or before January 1, 2026 and at least every four years thereafter.
