## **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

### Synopsis:

HM 10 requests that a joint task force be convened by the Children, Youth and Families Department and the Health Care Authority to help remedy the minimal behavioral health services and residential treatment facilities for older foster youth.

#### FISCAL IMPLICATIONS

HCA would need 2 FTE and 1 supervisor to assist with the taskforce, and importantly on implementing long term strategies from the recommendations and implement Medicaid services assisting the foster parents caring for youth who have mental and behavioral health needs. These FTE will assist CYFD and the MCOs in finding appropriate placement for these children, assist the task force in developing and implementing recommendations, and support CYFD as it recruits and retains trauma-informed foster parents. This would be a total of \$338,800 for a pay band 70 and .5 of a pay band 75 which includes salary, fringe, and operating costs.

#### **SIGNIFICANT ISSUES**

According to a Harvard University study, children in state custody cannot find placement due to the following:

- Systems problems: including capacity constraints, high acuity patients, frequent.
- readmissions, and the lack of outpatient resources.
- Payment issues, in terms of both payment rates and the structure of reimbursement.
- Leadership and collaboration problems, including the lack of strong leadership,
- interagency cooperation, and meaningful participation from all stakeholders.

These staff would assist the task force in developing and implementing long-term strategy recommendations. These positions would also assist in developing methods to recruit and retain trauma-informed foster parents who can care for older youth with mental and behavioral health needs. Involvement from Medicaid Managed Care Organization representatives is recommended as they will be responsible for implementing Medicaid policy reforms in the field.
