BILL SUMMARY

Synopsis:

House Memorial 15 will transfer the "Escuelita Building," in Las Trampas, New Mexico, from the Peñasco Independent School District to the Las Trampas Mutual Domestic Water Consumers Association.

FISCAL IMPLICATIONS

SIGNIFICANT ISSUES

The Peñasco Independent School District currently owns the Esceulita Building in Las Trampas, New Mexico, which served as the regional school from 1914 to 1961. The age of the building is unknown, but the existing building was sold to the school district in 1914.

The Las Trampas Mutual Domestic Water Consumers Association has leased the building from the school district since 1961, and has been responsible for the costs of electric service, maintenance and improvements since that time. The building serves more as a community center, and is not used by the school district for any educational or administrative purposes.

House Memorial would transfer ownership of the building from the current owner, the Peñasco Independent School District, to the long term tenant, The Las Trampas Mutual Domestic Water Consumers Association.

As this building is not used as an educational facility, it is not included in the Public School Facilities Authority (PSFA) database. Nor is the building included in the district's Facility Master Plan.
