## SECTION III: NARRATIVE

## BILL SUMMARY

HM20 requests that the Legislative Education Study Committee study class size reductions for kindergarten through twelfth grade classes, including potential effects on student outcomes, staffing and funding.

HM20 requests that the Legislative Education Study Committee work with representatives from the public education department, the higher education department, the legislative finance committee, the early childhood education and care department, leadership from school districts and charter schools, teacher unions and educator preparation programs. HM 20 requests that research findings and recommendations be submitted to the governor and legislature and be published by December 31, 2024.

The study is to be conducted taking into consideration that less than 1 in four students scored "proficient" in reading and math on the national assessment of educational progress tests in 2022; the large proportion of students identified as at-risk: one in four children living in poverty; higher than the national averages of English language learners and children with disabilities; and the marked impact of the corona virus pandemic on students and disrupted instructional time. Research that indicates that the reduction in class size can be an effective means to improve educational outcomes, student engagement and student behavior particularly in elementary grades.

Additional considerations of the study include high levels of teacher turnover, alternative licensure pathways for educators that require little to no classroom experience and the movement to lower classroom sizes would require hiring additional teachers and educational assistants as New Mexico continues to face workforce shortages in this area.

The Legislative Education Study Committee will work with representatives from the public education department, the higher education department, the legislative finance committee, the early childhood education and care department, leadership from school districts and charters schools, teacher unions and educator preparation programs. Research findings and recommendations to the governor and legislature and published by December 31, 2024.

## SIGNIFICANT ISSUES

The inclusion of NM PreK class sizes in the study would be beneficial as current research shows that PreK children in smaller classrooms are found to gain more in literacy skills by the end of preschool (Relating preschool class size to classroom quality and student achievement; Early Childhood Research Quarterly, Volume 49, 4th Quarter), improving kindergarten preparedness and establishing a stronger foundation for improved educational outcomes.
