Synopsis: House Memorial 45 requests that the New Mexico Coalition of Sexual Assault Programs, Incorporated, task force reconvene and continue its work to make its recommendations to the legislative Health and Human Services Committee, the interim committee dealing with Courts, Corrections and Justice issues and the Crime Victims Reparation Commission by November 1, 2024. The task force is to make recommendations for policy and legislative changes to improve jails' and detention and correctional facilities' compliance with the federal Prison Rape Elimination Act of 2003.
