BILL SUMMARY

Synopsis:

House Memorial 46 is a declaration by New Mexico House members to urge New Mexico's federal delegation to support the continuation of the federal Affordable Connectivity Program (ACP). ACP was established in 2021 as part of the Bipartisan Infrastructure Law and included a \$14.2 billion appropriation. The intent of the program is to help ensure that low-income households can afford the broadband they need for work, school, healthcare and more. The Federal Communications Commission was tasked with implementation of the ACP with states taking an active role in promotion and outreach. It is estimated that approximately 180,000 New Mexico households benefit from and rely on the ACP discount in order to be able to afford home Internet.

ACP provides a discount of:

- Up to \$30 per month toward broadband service for eligible households
- Up to \$75 per month for eligible households located on Tribal lands.
- Up to \$100 (one-time) to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.

Internet providers file claims for reimbursements associated with the discount through a program claims process managed by the Universal Service Administrative Company. Because Congress has not taken action to extend ACP, it is projected that funding will run out in late April, therefore applications and enrollments will not be processed after February 7, 2024 at 11:59 PM ET.

FISCAL IMPLICATIONS

At minimum \$5.2 million per month will not come into New Mexico via the subsidies. Currently there is no state funding or appropriation that can be used by OBAE to stand up a similar program.

SIGNIFICANT ISSUES

180,000 households will lose the ACP subsidy. This may cause households to stop internet services. Low-income households and tribal communities will be most impacted by the end of ACP. Telehealth, schooling, access to government services, and other online services will be unavailable to those households unable to afford the increased cost of services.
