BILL SUMMARY

Synopsis:

HB82 appropriates \$500.0 of general fund to the New Mexico Department of Cultural Affairs for expenditure in fiscal years 2024 through 2027.

Through roadside markers across the state, the New Mexico Historic Women Marker Program tells the stories of New Mexico women. Launched in 2006, the program has expanded its exploration of New Mexico's diverse multicultural women's history through curriculum, public outreach, and traveling exhibitions.

SIGNIFICANT ISSUES

According to program advocates, the appropriation will be used for the following purposes:

- Continue to include the New Mexico historic women marker program and the marker locations in the state's marketing campaigns and their marketing materials;
- Preservation, promotion and archiving of information, research and documentation of women's histories;
- Continue enhancement and widespread promotion and functionality of the Historic Women Marker website;
- Broadening implementation of the standards-aligned K-12 education curriculum created initially with the prior appropriation through program promotion and expanded educator-training provided to teachers;
- Increase partnerships to research and develop interactive materials and interactive videos for broader public education and outreach;
- Outreach to post-secondary educational women's studies programs to develop relevant historical research and coursework;
- Expand and sustain partnership with DCA and state museums, the state library and public

libraries statewide on integrating NM Historic women in exhibits, and continued development and support of the use of the Historic Women Marker educational banners; and

• Continue research and coordination with DCA and the department of transportation on the nomination process, location and placement of historic markers.
